Chairman Olson opened the floor to discuss Time Clocks. There was discussion on where the Commission left off with the issue. The Commission asked Auditor Larson to reach out to IT Palm to see if he has researched the cost, if it can be compatible with the courthouse's current accounts program, and if cameras would be the log in.

Chairman Olson opened the floor to discuss Old Courthouse/New Courthouse. There was discussion on the Chandelier and what needs to be done to make sure it is ready to be put up when delivered. The Commission would like Custodian Pfiefer to open up the ceiling panels to be able to see what is above them for the next meeting. Auditor Larson also reported that she got back in contact with NDSU and they would like to talk to a Commissioner so she gave Commissioner Urness their number and he will get in contact with them.

Chairman Olson opened the floor to future business. The Commission would like Old Social Services Building on the agenda for next meeting.

Motion by Pedersen to adjourn meeting at 3:31pm and meet again in regular session on February 8th, 2019 at 2:30 pm, second by Steffen and called three times for discussion with all ayes, no nays and carried.
