There was also discussion on the future and current road projects and the process going forward. Motion by Urness to set non-crop land value at \$1200/Acre for easements, second by Wakefield and called three times for

discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried. Motion by Urness to adopt the NDDOT minimum payment standards for easements, second by Pedersen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried. There was also discussion on the results from the gravel test on County Road 21 that was presented.

Chairman Olson opened the floor to Tax Equalization. There was discussion on the Ag land and Commercial valuations that were missed at Tax Equalization. The Commission are unable to reopen the meeting. Motion by Urness to draft a letter to the State Equalization Board requesting that the Ag land be brought up to 90% of the State Threshold for Griggs and the Commercial be brought down to 90% that was missed at Tax Equalization, second by Pedersen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried.

Chairman Olson open the floor to discuss the 2020 Budget. There was discussion on the Cost of Living increase that the County would like to use. Motion by Steffen to approve a 2% salary increase, second by Wakefield and called for discussion. Motion by Urness to amend the motion to move it to 3%, second by Pedersen and called three times for discussion with roll call vote: Wakefield-nay, Pedersen-aye, Urness-aye, Steffen-nay, Olson-aye, and carried. Chairman Olson called three times for discussion on the amended motion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-nay, Olson-aye, and carried. There was also discussion on the Longevity Raise that the employees request. No action was taken on the issue. There was also discussion on the County offering full family insurance. Motion by Wakefield to leave the policy the same as last year with only offering single policy health insurance, second by Pedersen and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried. The Commission reviewed the budgets that were presented and discussed them with the department heads that were presented. Motion by Steffen to remove the Assessment Software and GIS this year for Tax Director, second by Wakefield and called three times for discussion with roll call vote: Wakefield-aye, Pedersen-aye, Urness-aye, Steffen-aye, Olson-aye, and carried. There was continued discussion on the budget as presented.

Chairman Olson opened the floor to discuss July 5th. Motion by Steffen to close the courthouse offices on July 5th and hold the Regular Commission Meeting on the 3rd, second by Urness and called three times for discussion with all ayes, no nays, and carried.

Chairman Olson opened the floor to discuss the Old Courthouse/New Courthouse. There was discussion on the letter from the State Historical Society that was presented. The Commission would like the letter sent to NDSU to receive cost of historical documentation.

Chairman Olson opened the floor to discuss future business. No discussion was held.
