Motion by Wakefield to take Lori Eggermont off the checking accounts and add Madison Wallace to the checking accounts, second by Urness and called for three times for discussion with roll call vote: Wakefield – aye, Pederson – aye, Urness – aye and Olson – aye and carried.

Chairman Olson opened the floor to discussion on the 2019 budget. After reviewing all budgets, it was decided that the Commission needs to meet with IT Palm, Sheriff Straight, Human Services Langley, County Extension Agent Vig, and the Library Board. Several budgets were approved as is and the Auditor should have those finalized and a draft levy sheet sent to the Commissioners before the next meeting.

Chairman Olson opened the floor to Old Courthouse/New Courthouse. Discussion was held on the vote results and the process to move forward. The possibility of appointing a committee to continue the process was discussed, but it was decided to meet with Tax Director Lunde on the next steps.

Chairman Olson opened the floor to Alan Jacobson. He has a large amount of Water Board information and wondered where it should go. The Board directed him to give it to Water Board Secretary Eslinger and she will give him an inventory of items.

Chairman Olson opened the floor to Future Business. The following items will be discussed at the next meeting: Future of the old Courthouse with TD Lunde, Road Department, Weed Control, State's Attorney's suggested policy for medical marijuana (zero tolerance policy and prohibit employees from having a medical marijuana card.)
