Chairman Olson reopened the floor to 2019 Budget to discuss the Commissioners Salary. Motion by Urness to approve the 2019 Commission Budget to reflect \$6000 for salaries, second by Steffen and called three times for discussion with roll call vote: Wakefield-nay, Pedersen-nay, Urness-aye, Steffen-nay, Olson-aye, and failed.

Motion by Wakefield to adjourn meeting at 4:04 pm and meet again in regular session on July 20th at 1 pm, second by Urness and called three times for discussion with all ayes, no nays and carried.
