Chairman Olson opened the floor to discuss the Old Courthouse/New Courthouse. Auditor Larson reported that NDSU was over in the old courthouse measuring and doing their work at the moment. There was also discussion on the blueprints of the old courthouse building.

Chairman Olson opened the floor to discuss future business. The Commission will discuss 2021 budget at the next meeting and the public hearing will be at 6pm. The Commission will also discuss the 2019 Audit soon.

Motion by Pedersen to adjourn meeting at 3:50 pm and meet again in regular session on October 9<sup>th</sup> at 4:30 pm and special session on October 9<sup>th</sup> at 6 pm, second by Urness and called three times for discussion with all ayes, no nays and carried.
