There is a grant to pay for updating the plan and he just needs to sign it and return. Motion by Urness to accept bid from Heartland Contracting to update the Multi-Hazard Mitigation Plan and accept the grant from the ND DES, second by Tranby and called for discussion three times with roll call vote: Wakefield-aye, Tranby-aye, Urness-aye, Edland-aye, Pedersen-aye and carried. Two commissioners need to be assigned to the plan.

Chairman Pedersen opened the floor to discuss the ballot measures. State's Attorney Tenneson has language to continue the 10 mills for the highway department. Discussion of whether this needs to go on the ballot this year. State's Attorney Tenneson will research for next meeting. Combination of offices question for ballot was discussed. State's Attorney Tenneson presented the process to put this on the ballot. There will be more research done by State's Attorney Tenneson for the next meeting.

Chairman Pedersen opened the floor to discuss the Employee Manual. Motion by Wakefield to table until next meeting, second by Urness and called three times with all ayes, no nays and carried.

Chairman Pedersen opened the floor to discuss the Treasurer's Retirement Letter. Discussion held on the Commission's options to fill the position. State's Attorney Tenneson will research these.

Chairman Pedersen opened the floor to the tax abatement presented. Motion by Urness to approve the application for abatement for parcel 12-0000-03132-010, second by Tranby and called for discussion three times with roll call vote: Wakefield-aye, Tranby-aye, Urness-aye, Edland-aye, Pedersen-aye and carried.

Chairman Pedersen opened the floor to discuss the Old Courthouse/New Courthouse. State's Attorney Tenneson had a response from the bond attorneys and will follow up with the Bank of North Dakota and the lending bank.

Chairman Pedersen opened the floor to discuss future business. Items to discuss at next meeting are Social Service Director position, Permission for State's Attorney Tenneson to run in both counties, combination of Auditor & Treasurer offices and the county road mill levy should be discussed.

Motion by Urness to adjourn meeting at 4:01 pm and meet again in regular session on
March 17th at 2:30 pm, second by Tranby and called three times for discussion with all ayes, no
nays and carried.
